<sup>‡</sup> As stated in the *Skidmore College Catalog*: “Seniors with distinguished academic records may graduate *cum laude* (3.400–3.669 GPA), *magna cum laude* (3.670–3.799 GPA), or *summa cum laude* (3.800–4.000 GPA) upon the recommendation of the Committee on Academic Standing and with the approval of the faculty.” The faculty approved new criteria for College Honors at the April 30, 2010, Faculty Meeting. Beginning with the Class of 2014, the *Catalog* will list the new criteria as follows: “Seniors with distinguished academic records may graduate *cum laude* (3.650-3.749 GPA), *magna cum laude* (3.750–3.899 GPA), or *summa cum laude* (3.90–4.00 GPA) upon the recommendation of the Committee on Academic Standing and with the approval of the faculty.”
