CEPP met 23 times during the 2017-2018 academic year, including two retreats in January and May. Individual members of CEPP also facilitated weekly meetings with the Black Studies subcommittee and with the General Education Curriculum working groups. The co-chairs of CEPP are also members of the Institutional Policy and Planning Committee and the Advisory Committee on Off-Campus Programs.

General Education Curriculum Working Groups

- Much of CEPP's business this year focused on organizing and facilitating
 working groups that created criteria for the new general education curriculum.
 CEPP held two open forums to solicit feedback regarding the criteria that the

- CEPP will continue to work with Curriculum Committee to clarify the working groups' recommendations.

Proposed Black Studies Minor

• In collaboration with the DOF/VPAA's office, CEPP continued to work on a proposal for a Black Studies minor. The co-chairs of CEPP met with the DOF/VPAA, CIGU, and the Black Faculty Staff Group to coordinate a subcommittee of CEPP tasked with writing a proposal for a Black Studies minor. That subcommittee met six times over the course of the year and developed a proposal that CEPP sent to Curriculum Committee. The process of developing a Black Studies minor will continue next year as CEPP responds to CC's concerns.

Other Business

- CEPP endorsed the 2019-2020 Academic Calendar.
- The committee endorsed three department/program name changes: Latin American Studies (minor) has become Latin American and Latinx Studies. Health and Exercise Sciences (Major) has become Health and Human Physiological Sciences. The Department of Mathematics (major) has become the Department of Mathematics and Statistics. CEPP also endorsed a new Statistics minor in the Department of Mathematics and Statistics
- The Chair of Curriculum Committee met with CEPP on two occasions to discuss potential certificate programs. The committee also met with Jordana Dym, director of MDOCs, to discuss a possible certificate program in MDOCs.
- CEPP had discussions with the Assessment Coordinator regarding assessment of information literacy. These conversations will continue.
- CEPP met with Paul Benzon, director of Project VIS, and Barbara Norelli,
 Scribner Library librarian, to discuss visual literacy and information literacy.
- Grace Burton, World Languages and Literatures, joined CEPP to discuss peer observation rubrics and potential policies.
- In anticipation of a review of the current Student Ratings form, Michael Arnush, chair of Classics and previous chair of CEPP, joined the committee to provide history and context for the development of the current form.
- CEPP discussed and generally supported a proposal from Athletic Council to add varsity sports as part of the physical activity offerings.
- Interim DOF/VPAA Crystal Moore proposed that the new Faculty Director of Assessment become a permanent member of CEPP. In the fall of 2018 CEPP will confer with FEC on this issue. Because it will mean a change to the Faculty Handbook, this decision will require a faculty vote
