### *Summary of Activities, Responsibilities, & Decisions*

The FDC met bi-weekly during the Fall semester and often weekly during the Spring semester. The purpose of these meetings included the development of new initiatives in support of faculty development; the evaluation and revision of some FDC practices for soliciting award nominations and proposals; the review of research proposals; the selection of the annual Edwin Moseley Faculty Research Lecturer and the Ralph A. Ciancio Award for Excellence in teaching; assisting the student body in the selection of the faculty speaker for commencement; and representing the faculty on the awarding of support for sabbatical leaves. In addition, Mary Ann Foley represented FDC in preliminary conversations with members of CEPP and others regarding the establishment of a new Center for faculty excellence and development.

### *New Initiatives*

The functions of the FDC include advising the Dean of the Faculty on faculty development policies and recommending new initiatives in support of faculty development and professional growth. In keeping with this charge, FDC submitted a proposal to the Dean of Faculty recommending an increase in the level of support for Travel-to-Read. This recommendation was included in the Dean of Faculty's request for new initiatives for the coming academic year. FDC submitted a second proposal for sabbatical support recommending the establishment of a new budget line in the DOF Operating Budget for additional sabbatical funding. This recommendation was not included in the Dean of Faculty's budget requests for the coming academic year. FDC recommends resuming discussion about this proposal next year with the Dean of Faculty, with a plan to resubmit the proposal before the next round of budget requests are submitted in the Fall of 2008. Before the end of the current academic year, FDC sent a memo to the Dean of Faculty and Vice President for Academic Affairs recommending that the level of sabbatical support available (by way of discretionary funds) for the next

round of sabbatical applications be at a level at least equivalent to the level available for this year's applicants. FDC also recommended that the level of funding should be announced before the deadline for the next round of sabbatical proposals.

#### *Changes in Guidelines & Practices*

FDC introduced several changes in our guidelines and practices that have helped facilitate the solicitation of award nominations and grant proposals. The online nomination process for the Moseley and Ciancio awards went very smoothly, and will be continued in the coming year. With revisions to the guidelines for the Faculty/Student Summer Research Program (increasing the flexibility in the kinds of proposals that might be supported), there was a record number of submissions this year, and a large number of proposals supported. FDC also instituted a change in the proposal grant categories. Beginning Academic Year 2009/10, the funding allocated for the Summer Technological Grants will be folded into the funding category for Faculty Development Proposals. Historically, this category of funding for technological innovations was intended to increase the number of faculty using computers in their work (a goal we have certainly surpassed). Because the number of proposal submissions to the general category of funding has increased in recent years, this change in categories of funding will increase flexibility in the awarding of grants. The sort of technology-related projects funded through this category in recent years may still be funded by way of the faculty development proposal review cycles. This new proposal submission process goes into effect in the coming academic year.

#### *Expressions of Appreciation*

FDC invited Bill Tomlinson, our Sponsored Research Officer, to join in discussions of FDC proposals, providing one relatively quick way for Bill to learn about faculty projects (involving research and/or teaching innovations). Bill will continue to join the FDC meetings involving the discussions and decisions regarding faculty grant proposals.

As he heads to England, and moves from the Dean of the Faculty Office, FDC expresses appreciation to Mark Hofmann for his guidance and support in his work with FDC as Associate Dean. Mark's leadership and efforts were greatly appreciated, most notably, his work to increase funding opportunities for summer research projects.

FDC also appreciates the decision of Muriel Poston, Dean of the Faculty, and Susan Kress, Vice President for Academic Affairs, to include FDC in discussions regarding sabbatical funding. Although sabbatical proposals have been reviewed by FDC for many years, there has been no involvement in decisions about funding. Initiated two years ago, FDC's involvement in these discussions has served to make more transparent the process of requesting sabbatical funding. The Dean of Faculty also joined FDC for a few additional meetings as FDC reviewed proposals, discussed policies, etc. These meetings led to productive discussions and future plans as well.

Last but far from least, FDC extends appreciation to Jill Jones and to Sue Blair for their help in supporting the work of the committee.
