The year in summary

The FDC met 10 times during the year. Our work was suspended in mid-March due to the Covid-19 emergency and the subsequent requisitioning of funds by the college. Thus we were unable to award spring Faculty Development Grants, spring emeriti grants, and the Ciancio Prize.

Nonetheless, we did choose the recipients of the Phyllis Roth Distinguished Service Award and the Edmund Moseley Faculty Lectureship, approved 8 sabbatical enhancement awards, and awarded 24 fall Faculty Development Grants, 2 emeriti grants, 5 Faculty Initiative Grants, and 30 Faculty-Student Summer Research Awards. Due to the Covid-19 situation, which will likely hamper travel and research plans, the Dean's Office has extended the deadlines for the use of the monies awarded. Please see the attached list for names and awards.

Committee Initiatives

This year FDC discussed the impact of Skidmore's changing faculty makeup on current committee membership requirements and criteria for awarding grants. Currently, full-time, non-tenure-track faculty are roughly 35-37% of the faculty at Skidmore, but are not recognized in FDC membership or grant criteria. The exclusion of NTT faculty from serving on FDC limits the pool of faculty members able to serve. The growth of NTT faculty also means that a larger portion of faculty may be excluded from faculty development awards. FDC worked on two related initiatives to address this situation.

→ **New membership configuration:** FEC has had difficulty meeting the divisional and seniority requirements of FDC. In response, FDC approved a change in membership allowing up to two members of the committee to be non-tenured in order to increase the pool of eligible faculty members and to

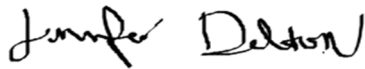
acknowledge the changing makeup of our faculty. FDC will bring a motion to the faculty floor in September 2020 to change the Faculty Handbook language regarding FDC membership.

→ **Changing the priorities/criteria in Faculty Development Grants:** The current FD Opportunities Handbook gives priority in awarding grants first to meritorious proposals. After that, the first priority is to fulltime tenured and tenure-track faculty, and secondarily to fulltime continuing non-tenure track (NTT) and temporary faculty, and lastly, to part-time continuing and temporary. FDC is proposing to prioritize junior tenure-track applicants, and give second priority to tenured, full-time NTT and full-time, multi-year temporary faculty, deciding cases on the basis of previous awards. Those who have not received awards recently will be favored over those who received many awards in the past. These changes will need to be approved by the Dean, but not the faculty.
