

# **Skidmore College Tuition Exchange (TE)**

# **Questions and Answers**

# Info Sheet for Skidmore Employees

### Q. Who may apply for the Tuition Exchange Program (tuitionexchange.org)?

A. Full-time faculty and staff (and employees holding shared appointments), who have completed three years of consecutive full-time employment, are eligible to apply for TE participation on behalf of their dependent children. See skidmore.edu/benefits/summary/tuition/tuition-exchange-program.php and/or contact Human Resources for more details concerning employee eligibility as well as dependent eligibility.

# Q. Are all eligible dependents certified by Skidmore for TE consideration or does Skidmore use seniority and/or a lottery system?

A. Throughout the history of the TE Program at Skidmore, all eligible employee dependents have been certified by Skidmore. For TE applications submitted for the 2026-2027 academic year, Skidmore anticipates the same.

#### Q. How does a student apply for TE?

A. New **student** applicants create an account at te.tuitionexchange.org. This will then enable the student applicant to login and complete the TE EZ-Application. The student's email should be one that will remain with them after graduating high school. Student applicants can add/delete from their list of schools. A student's maximum number of active schools is twenty. The student applicant enters the employee (parent) information. The employer ID is \*not\* a required field. Once the student clicks "SUBMIT", the EZ app is shared with Skidmore's TELO who reviews and confirms eligibility with Human Resources at Skidmore. Assuming the employee meets Skidmore's guidelines for TE eligibility, the TE Liaison will certify the EZ app and the schools listed on the app will receive the TE application.

At this point, the importing schools take over the EZ application review process. The importing schools will notify the exporting TELO, Skidmore employee and student applicant once the Tuition Exchange decision has been made using the email addresses entered on the TE EZ app. This usually occurs in early spring but may be earlier if a student is an early decision applicant. TE applicants should complete the admission applications and any required financial aid applications according to each school's deadlines.

#### Q. What are my chances that the TE college will award my dependent child a scholarship once eligible?

A. It depends on the participating TE college's policies and procedures, and the number of TE scholarships it has available. TE can be highly competitive at some institutions. It is recommended that you "conduct a school search" on TE's website to get a better feel for an institution's TE school profile. From www.tuitionexchange.org, select "Families", select "Tuition Exchange School Search". For more specific questions on a particular school's TE program, contact the TELO at the importing institution.

## Q. When should I apply?

A. Your student should apply no later than the earliest college admission deadline of the colleges that your dependent child is considering. It is a good idea to apply for financial aid at the same time the admission application is filed for institutions being considered, should financial aid be necessary for enrollment. If the student waits to find out if a TES is offered before applying for aid, it may be too late to apply for the participating college's grant aid. Also, even if a TE Scholarship is offered, the student may need financial assistance beyond the TE Scholarship. It is recommended you learn how competitive TE is at the institutions being considered.

# Q. What is the value of a TE Scholarship?

A. For 2026-2027, TE colleges are required to cover at least \$44,000 of their charged tuition. This is called the minimum "set rate" value. If the tuition is higher, the participating TE college may offer a TES covering all or some of the remaining tuition cost. If the tuition is lower, the participating TE college may reduce the TES by federal, state and/or institutional scholarships. The TE website is a good resource to learn about an export's TE policies. Each year the Tuition Exchange Board of Directors establishes the set rate value amount based on a weighted average of all participating TE schools.

#### Q. What is the cost to the employee for a dependent student receiving a TES?

A. The employee pays an annual administrative fee charged by Tuition Exchange. For 2025/2026 the fee is \$55 per student. Skidmore's TELO will request the fee via email mid to late August and ask the employee to confirm the dependent is receiving the TES for the upcoming academic year.

### Q. What happens if too many students apply for TE at a particular TE college?

A. Each participating TE college determines whom they will accept, and how many students will be offered a TE Scholarship. The criteria used could include, but is not limited to, SAT/ACT scores, class rank, teacher recommendations, activities, financial need, and/or an employee's length of service.

#### Q. Can my child receive a TE Scholarship and use the external tuition benefit at the same time?

A. Your child is eligible to receive either the TES or the external benefit (if eligible) within a given semester but not both at the same time.

# Q. How were Skidmore's TE policies and procedures developed?

A. An advisory committee established the original guidelines with approval by the College's committee structure and President's Cabinet. Although TE is not part of Skidmore's benefit package, the advisory committee felt the TE program should be consistent with other college-administered offerings.

#### Q. Who administers Skidmore's TE program?

A. The Associate Director of Financial Aid acts as the Tuition Exchange Liaison Officer and is responsible for the administration of the program on a daily basis. Human Resources is responsible for maintaining Skidmore's TE policies.
