Annual Report for the Institutional Review Board FY 2016

This report describes the activities of the Institutional Review Board (IRB) beginning June 1, 2015 and ending May 31, 2016 (FY 2016).

As shown in Table 1, 50 new protocols were submitted to the IRB during FY 2016. Most proposals were classified as expedited (50%) or exempt (40%). Two protocols (4%) were received but determined not to constitute human subjects research. Three protocols (6%) were reviewed and returned to the investigator with suggested edits, but as of May 31, 2016, have not been approved. No new protocols required full-board review by the IRB.
