Annual Report for the Institutional Review Board - FY24

This report describes the activities of the Institutional Review Board (IRB) beginning June 1, 2023 and ending May 31, 2024 (FY24).

As shown in Table 1, 70 new protocols were submitted to the IRB in FY24. Of these 70 protocols, 24 were classified as expedited (34.29%) and 40 were classified as exempt (57.14%). Two protocols were classified as Not Human Subjects Research (2.86%), and 4 protocols (5.71%) were submitted but later withdrawn.

Continuing Review Forms were sent to investigators for 14 protocols classified as expedited and full-board that were approved prior to January 21, 2019 (those approved after January 21, 2019 do not require continuing review). Nine protocols received approval to remain active, while 5 protocols either received approval to be closed or were administratively closed due to non-response by the PI.

No adverse events or protocol violations were reported to the IRB in FY24.
