Administrative Roles and Accomplishments

Dean of the Faculty and Vice President for Academic Affairs (2011-2018)

Skidmore's chief academic officer provides visionary leadership for the Academic Affairs division of the College (400+ faculty, 500+ employees, 40 direct reports). S/he/they oversee all academic departments and programs, the faculty, the Library, the Office of the Dean of Special Programs (primarily responsible for all summer programs), the Tang Teaching Museum and Art Gallery, the Registrar, the Office of the First-Year Experience, Off-Campus Study and Exchanges, the Higher Education Opportunity Program, the Office of Academic Advising, The College's Assessment office, Institutional Research, Sponsored Research, the Center for Leadership, Teaching, and Learning, the Student Academic Development Coordinator, the Institutional Safety office, the Campus Sustainability office, and several Associate Deans. The Operating Budget for Academic Affairs is roughly \$65 million. Skidmore's CAO partners with all offices on campus, including Admissions, Student Affairs, Finance and Administration, and Advancement. S/he/they also liaises with the entire Board of Trustees and sits on a dozen all-college committees, including the Institutional Policy and Planning Committee, the Committee on Educational Policies and Planning, the Assessment subcommittee of IPPC, and the Enrollment Management Committee. The CAO also works with the College's Advancement office to cultivate donors, participate in alumni events and admissions open houses, identify institutional priorities, and strategize about fundraising possibilities. Most importantly, perhaps, Skidmore's chief academic officer is the primary advisor to the college president.

Key accomplishments include:

- Led the College's overhaul of the entire General Education Curriculum
- Led the College's successful reaccreditation effort (Middle States).
- Partnered with President and other institutional leaders in creating the Strategic Plan (*Pathways to Excellence: The Plan for Skidmore College 2015-2025*).
- Hired 100+ tenure-line faculty, half of whom are faculty from underrepresented groups (<https://www.chronicle.com/article/A-Liberal-Arts-College-/231723>).
- Created "Just-In-Time Inclusive Hiring Program" that has become a national model.
- Increased a sense of inclusiveness and belonging for all colleagues in Academic Affairs.
- Increased the number of tenure track faculty by 18 (from 198 tenure lines in 2011 to 216 in 2018)
- Substantially increased resources for faculty-student research, faculty sabbatical enhancement awards, travel to read and rep.
- Initiated Associate Chair program to reduce workload of department/program chairs
- Allocated significant resources/joined national organizations to hire and retain faculty of color, including Consortium for Faculty Diversity (CFD), the National Center for Faculty Development and Diversity (NCFDD), University of Michigan Center for Research on Learning and Teaching (and especially the CRLT players).
- Led the design, program, and early construction of the College's Center for Integrated Sciences complex (a 175,000 sq. foot addition to our existing science building)
- Doubled external grant money to faculty/institution.
- Secured multiple million dollar grants from the Andrew W. Mellon Foundation, the Arthur Vining Davis Foundations, The Teagle Foundation, the Robert H. N. Ho Family Foundation, the Emerson Foundation, the Alden Trust, the National Science Foundation, the Henry Luce Foundation, and more.
- Increased the College's focus on data-driven decisionmaking.
- Strategic partner with Dean of Admissions and others on enrollment and financial aid strategies
- Founded the Center for Leadership, Teaching, and Learning
- Oversaw our initial foray into AASHE STARS rating system (received Silver rating)
- Partnered with Advancement on numerous fundraising initiatives, including, most recently, a \$5 million gift to found the Moore Documentary Studies Collaborative.
- Partnered with Advancement on the creation of three additional endowed chairs.

- Introduced many programs aimed at increasing access and opportunity to all students, but especially students from underrepresented groups/first-gen/Pell-eligible
- Oversaw the effort to create several new disciplinary and interdisciplinary academic departments/programs (Black Studies, Media and Film Studies, Documentary Studies Collaborative).
- Introduced initiatives to support non-tenure line faculty in a variety of ways, including increased pay, increased opportunities for career advancement/promotion, and increased participation in the life of the College.
- Partnered with faculty and other colleagues on several extensive *Faculty Handbook* language changes, including ones aimed at increased clarity on tenure and promotion processes/expectations and reducing faculty workload.
- Implemented a substantial program where faculty receive teaching credit for all self-directed studies (independent studies, senior theses, collaborative research, internships).
- Senior Provost in the New York Six consortium (Colgate, Hamilton, Hobart and William Smith, Skidmore, St. Lawrence, and Union).
- Collaborated with Student Affairs, Admissions, and other offices on New Student Orientation, Housing issues, co-curricular programming, etc.

Assistant Dean of the Faculty (2008-2011)

The Assistant Dean of the Faculty (now known as the Director of the Center for Leadership, Teaching, and Learning) oversees all faculty development initiatives, including the faculty mentoring program, the “New Faculty Orientation program”, the “New Faculty Learning Community”, extensive writing groups, various affinity groups, implicit bias trainings, and NYSix faculty development programs. The annual program budget for this office is approximately \$50,000.

Key accomplishments include:

- Inaugural Assistant Dean—many of the programs were founded under my watch.
- Established a mentoring program for all incoming faculty
- Secured the Mellon grant to fund the Center for Leadership, Teaching, and Learning
- Doubled the faculty development funding for “Travel to Read and Represent,” Sabbatical Enhancement,” “Faculty-Student Collaborative Research”.
- Emphasized inclusivity and belonging as fundamental principles of our mission.

Director of the First-Year Experience (2007-2011)

The Director of the First-Year Experience leads the curricular and co-curricular programming aimed at providing an intellectual and social toolkit for all incoming students. S/he/they oversee all Scribner Seminars (45 first year seminars offered each fall), the recruitment of faculty for the Seminars, the New Student Orientation, the Fourth Credit hour, all co-curricular offerings (partnering with Student Affairs), the London program, enrollment matters, and most Admissions materials (partnering with Admissions and with Communications and Marketing). The annual program budget for the FYE is approximately \$60,000.

Key accomplishments include:

- Enhanced collaboration with Student Affairs and Admissions
- Provided increased training and support for faculty teaching in the program
- Started the peer mentoring program and provided critical training
- Expanded and Improved New Student Orientation
- Created Diversity and Inclusion programming for faculty and students
