Meeting minutes:

Minutes from September were accepted *Updates

Highlights of discussion:

SAS serves approximately 250 students with disabilities and nearly as many international students. The staff provides direct academic counseling and coaching to all interested Skidmore students with emphasis on students with disabilities, international students, student athletes and students of color. They work closely with the Office of Academic Advising (OAA) and the Opportunity Program (OP) to monitor student progress toward degree completion and to coordinate academic and personal intervention services when necessary. SAS coordinates the peer tutoring program for Skidmore across the curriculum. Peer tutoring is delivered as individual sessions and drop-in tutoring.

One of the major services provided to students with disabilities is alternative/accommodative testing. Over the past several years this has proven a major growth area and has gone from roughly 330 exam in the fall of 2013 to over 550 last spring. There are a total of 16 testing seats in the space, so at times, need to run services remotely.

The Student Assessment and Intervention Group (SAIG) is composed of a variety of Student and Academic Affairs staff and Campus Safety. Representatives meet once each week and as needed. The group has evolved from a threat assessment team to one that monitors student and campus issues and provides students with behavioral and academic intervention services.
